

## **Food Allergy Canada “All about food allergy” sweepstakes rules and regulations**

THE FOOD ALLERGY CANADA “ALL ABOUT FOOD ALLERGY” SWEEPSTAKES (THE “SWEEPSTAKES”) IS INTENDED TO BE CONDUCTED IN CANADA ONLY (EXCLUDING THE PROVINCE OF QUEBEC) AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE FEDERAL, PROVINCIAL, TERRITORIAL AND MUNICIPAL LAW. NO PURCHASE IS NECESSARY. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. BY ENTERING THIS SWEEPSTAKES, YOU ACCEPT THAT YOUR PARTICIPATION AND THE SWEEPSTAKES WILL BE GOVERNED BY THESE SWEEPSTAKES RULES, WHICH RULES CONSTITUTE A BINDING AGREEMENT BETWEEN THE ENTRANT AND FOOD ALLERGY CANADA WITH RESPECT TO THE SWEEPSTAKES (“SWEEPSTAKES RULES”).

### **1. ENTRANT ELIGIBILITY**

To be eligible for this Sweepstakes, you must be: a legal resident in Canada, excluding Quebec; not be an employee or consultant of Food Allergy Canada (“the Sponsor”), or domiciled with any such person or the immediate family member of any such person. For the purposes of these Sweepstakes Rules, “immediate family member” means parent, child, sibling, spouse, in-laws, grandchild or grandparent. Only individuals meeting these requirements will be considered eligible entrants (the “Entrant”). The Sponsor has the right at any time to require proof of an Entrant’s eligibility to participate in the Sweepstakes. Failure to provide such proof may result in disqualification. All information supplied to the Sponsor for the purpose of the Sweepstakes must be truthful, complete, accurate and in no way misleading.

### **2. FOOD ALLERGY CANADA**

Food Allergy Canada is a not-for-profit charity continued and existing under the Canada Not-for-profit Corporations Act (Canada), located at 505 Consumers Road, Suite 507, Toronto, Ontario, M2J 4V8.

### **3. TERM**

The Sweepstakes begins 12:00 a.m. Eastern Daylight Time (“EDT”) on September 3, 2024, and ends 11:59 p.m. EDT on June 9, 2025 (the “Sweepstakes Period”). All Sweepstakes Entries will be entered into the Sweepstakes draw. Ten Entries will be randomly selected by Food Allergy Canada and will be contacted by June 10, 2025, by 11:59 p.m. EDT.

### **4. HOW TO ENTER**

Successfully complete and submit the registration form for the “All about food allergy” school for grades 4-6 program (the “Entry”).

The registration form is valid for one ballot in the Sweepstakes per school year. Participants will only be entered once per school year into the contest regardless of the number of submissions provided through the contest entry form.

During the Sweepstakes Period, Entrants must submit their completed registration form at [foodallergycanada.ca/SchoolProgram](https://foodallergycanada.ca/SchoolProgram). In addition, Entrants must complete the [program survey](#) by June 9, 2025, at 11:59 p.m. EDT. All Sweepstakes Entries will be recorded at the time of submission which will be used to determine eligibility for the Sweepstakes draw.

By entering this Sweepstakes, you acknowledge that your submission may be posted on Food Allergy Canada's website, social media, or other places where the "All about food allergy" school program is discussed. If you do not want your school posted, please email us at [info@foodallergycanada.ca](mailto:info@foodallergycanada.ca) and we will ensure it will not be shared.

By entering the Sweepstakes, Entrants agree to accept and abide by the Sweepstakes Rules. All decisions of the Sponsor with respect to any aspect of this Sweepstakes, including without limitation the eligibility of any Sweepstakes Entries, are final and binding for all Entrants in all matters as they relate to this Sweepstakes.

## 6. WINNER SELECTION

Ten (10) Entries will be randomly selected by Food Allergy Canada in a draw on June 10, 2025, on or about 12:00 pm EDT in Toronto, ON from all eligible Sweepstakes Entries received during the Sweepstakes period. The odds of being one of the ten winners will depend on the total number of eligible entries received during the Sweepstakes period. Participants will only be entered once into the Sweepstakes, regardless of the number of submissions provided.

There are 10 prizes (as described below), where 1-of-10 prizes will be awarded to each of the winners. The winners will be announced on Food Allergy Canada's website by June 16, 2025, on or about 12:00 pm EDT in Toronto, ON.

Winner Notification: The winner will be contacted by email (using the contact information provided by Entrant at time of entering the Sweepstakes) on the corresponding date (as per the above), a maximum of two (2) times via email. If the potential winner(s) cannot be contacted or reached within 5 business days, the runner-up(s) will be selected, and the initial selected winner(s) will be disqualified and will have no recourse towards the Sponsor, or anyone involved in the Sweepstakes. The winner must correctly answer a mathematical skill testing question, without aid or assistance, in writing before being declared a winner. Failure to correctly answer the skill testing question will result in forfeiture of the prize, and the Sponsor reserves the right to select a potential alternate winner from the same pool of Entrants. Each potential winner must execute and return within five (5) days of receipt a standard Declaration and Release Form, including a publicity release, and any other documentation that the Sponsor requires (the "Prize Acceptance Documents"). Except where prohibited by law, by accepting the Prize, the winner consents to the use by the Sponsor of his/her name, school name, and address (city and province only) for advertising/publicity purposes worldwide and in all media, without further compensation. Winning entrants will consent to any good faith requests for photographs or interviews and or other reasonable requests to publicize their success in the Sweepstakes and their use of the prize.

Sponsor reserves the right to disqualify a winner and to select a different winner, in Sponsor's sole and absolute discretion, if Sponsor determines, at any time prior to awarding the Prize, that the Entrant has not complied with these Sweepstakes Rules.

## 7. THE PRIZES

There are ten (10) prizes available to be won. The winners will receive 1-of-10 gift cards of \$200 for their school. The gift cards will either be VISA gift cards, or gift cards that can go towards buying supplies for the winner's classroom.

The prize details will be emailed to the confirmed winner. Prizes must be accepted as awarded without substitution, are not transferable, and are not for resale. The Sponsor reserves the right, in the event that a Prize or a Prize component cannot be awarded as described for any reason (as determined by Sponsor in its sole discretion), to substitute another prize or prize component of equal or greater value, without liability.

Sweepstakes is subject to the Sweepstakes Rules and all applicable federal, provincial and local laws. The Sponsor makes no express or implied warranties or conditions of any kind with respect to any prize or prize activity offered. Other restrictions may apply.

## 8. LIABILITY AND INDEMNITY

By entering the Sweepstakes, the Entrant confirms the Entrant's eligibility for the Sweepstakes, compliance with Sweepstakes Rules, acknowledgement of the Prize offered, and hereby releases and holds the Released Parties harmless from any and all liability for any injuries, loss or damage of any kind whatsoever to the Entrant or any other person, including personal injury, death, or property damage, and cost or expense, resulting in whole or in part, directly or indirectly, from acceptance, possession use or misuse of any Prize, participation in the Sweepstakes, any breach of the Sweepstakes Rules, or any other related activity. The Entrant agrees to fully indemnify Sponsor and its affiliates from any and all claims by third parties, as related to the Sweepstakes, without limitation.

Proof of transmission does not constitute proof of delivery. Sweepstakes Entries must be made by the original, manual keystrokes of individual Entrant. Use of any automated system including robotic or form filling software to enter or participate is prohibited and will result in disqualification of all entries by anyone using such assistance. The Sponsor assumes no responsibility for garbled, lost, delayed, damaged, late, incomplete or destroyed Entries or Prize Acceptance Documents or any computer errors or malfunctions. No correspondence will be entered into except with the potential winners. The Sponsor does not assume any responsibility for incorrect or inaccurate capture of entry information, technical malfunctions, human or technical error, seeding or printing errors, lost, delayed or garbled data or transmissions, omission, interruption, deletion, defect or failures of any telephone or computer line or network, computer equipment, software or any combination thereof. The Sponsor reserves the right to cancel, terminate, modify, amend, extend or suspend this Sweepstakes or the Sweepstakes Rules in any way, without prior notice. Without limiting the foregoing, if for any reason, in the opinion of the Sponsor in its sole discretion, the Sweepstakes is not capable of running as originally planned, or if the administration, security, fairness, integrity or the proper conduct of the Sweepstakes is corrupted or adversely affected, including by reason of infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures or any other causes beyond its control, the Sponsor reserves the right, to cancel, terminate, modify, amend, extend or suspend the Sweepstakes, including cancelling any method of entry, and select winners from previously received eligible entries. The Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of the Sweepstakes Rules or otherwise in a disruptive manner. The Sponsor, in its sole discretion, further reserves the right to terminate the Sweepstakes and declare a winner from among the eligible entries received up to the point of termination. Any attempts to deliberately undermine the legitimate operation of this Sweepstakes is a violation of criminal and civil laws and should such an attempt be made the Sponsor reserves its right to seek remedies and damages to the fullest extent of the law. The Sponsor shall not be held responsible

for any errors, negligence, injury, loss or damage that may arise or occur in connection with the Sweepstakes, including any damage to an Entrant's computer equipment, mobile device, system, software or other property or any combination thereof, as a result of their participation in this Sweepstakes or from downloading any material from the Sweepstakes Website, where applicable.

#### 9. PRIVACY

By participating in the Sweepstakes, the Entrants grant Food Allergy Canada the right to use his/her name, school name, and email address ("Personal Information") for the purpose of administering the Sweepstakes, including, but not limited to, contacting and announcing the winner.

Food Allergy Canada respects your privacy and is committed to protecting the information you share with us. Food Allergy Canada confirms that any Personal Information you provide to us will only be collected and/or used for the purposes of the Sweepstakes, as provided for in the Sweepstakes Rules, and will be managed in accordance with Food Allergy Canada's privacy policy (found at [foodallergycanada.ca](http://foodallergycanada.ca) and/or applicable laws).

#### 10. GOVERNING LAW

This Sweepstakes shall be governed by the laws of Ontario and the laws of Canada applicable therein. Any dispute with respect to the Sweepstakes shall be determined by a court of competent jurisdiction in Ontario and the Entrants hereby agree to attorn to the jurisdiction of the Ontario courts for the purpose of the resolution of such dispute.
